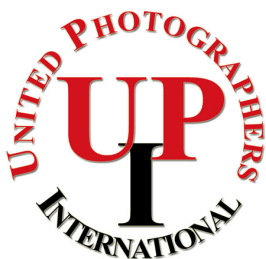

CONDITIONS OF ENTRY

United Photographers International - UPI, cordially invites photographers from all over the world, amateurs as well as professionals, to participate in the "2nd UPI International Exhibition of Photography 2012". It will be conducted in accordance with UPI and PSA requirements.

The exhibition is open to anyone; however, an entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believes the entry does not conform to exhibition rules and conditions.

Entries must originate as photographs (image-captures of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his own and permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. The exhibition assumes no liability for any misuse of copyright.

Images may be altered, either electronically or otherwise, by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates.

The subject is free. There are two sections: Colour and Monochrome.

Each entrant may submit a maximum of four entries in each section.

All entries must be sent as Digital Images by e-mail to:

in JPEG format with maximum horizontal dimension 1024 px

and the maximum vertical dimension 768 px.

Maximum file size 500 kb.

CD/DVDs will not be accepted!

The entrant certifies that he is the sole owner of all the rights and elements on the image which he presents.

Entries will not be judged without an entry form, available on the website www.upiphoto.com, together with the full payment of entry fee.

Fee can be paid by PayPal (preferably) to nils.erik.jerlemar@profa.se or sent in cash.

Notification will be sent by e-mail.

Each entrant will receive a high quality salon CD catalogue.

An entrant's four images will be presented to the judges consecutively, and the decision of the judges is final.

The submission of entries signifies acceptance of the Conditions of Entry.

IMAGE FILE NAME

The Exhibition has two sections:

- A. Colour
- B. Monochrome

The appropriate section letter (A, B) must be used as part of the Electronic File Name. Your surname and the initial of your first name will be used as the first part of the Electronic File Name as shown below:

surname-X-####-YZ.jpg

Surname is your Family name. "X" is the first character (Initial) in your given name.

is the last four digits of your phone number.

"Y" is the Section letter (A, B) & "Z" is the image number (1-4) of the entry.
